## Educational items for students to own:

### BYOD is compulsory for students in Years 7, 8, 9 and 10.

"Bring Your Own Device" (BYOD) refers to students bringing a personally owned device (Microsoft based Laptops and Netbooks) to school for the purpose of learning.

### How will my child be using their device during the school day?

Students will use their registered devices to complete in-class activities, check their student portal, collaborate in real time, research for projects, and access websites with curriculum-related content.

A number of parents have asked about recommendations for specific brands and models of Netbooks/Laptops. Students may use any model or brand as long as it meets the specifications as listed. It is recommended that all devices have an application which will provide the equivalent to the following elements of the Microsoft Office Suite: word processing, spreadsheet and presentation software [Word, Excel and Power Point] and a web browser.

**Preferred devices are:** Microsoft based Laptops and Netbooks.

### Extra-Curricular Items and Activities:

Doncaster Secondary College offers a range of items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides in order to deliver the Curriculum. These are provided on a user-pays basis.

## Payment methods

Parents and guardians will be provided with early notice of payment requests for Curriculum Contributions, Other Contributions and Extra-Curricular Items and Activities. There will be a minimum of six weeks' notice prior to the end of the previous school year.

To further assist parents / guardians with payments, payment options have been developed, including:

- Option A** Full amount by the beginning of Term 1
- Option B** Payment instalments; or
- Option C** Other payment arrangements, including individual payment plans.

# PARENT PAYMENTS POLICY

## ONE PAGE OVERVIEW



### FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.



### PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

#### Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

#### Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

#### Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



### FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



### SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
