## PURPOSE

The purpose of this policy is to provide guidance to the College community around working with a School Dog to enhance wellbeing and engagement. The Social and Emotional Learning (SEL) competencies which can be developed through having a School Dog are linked to Victorian Curriculum standards, and are addressed in Discovery under the Resilience, Rights and Respectful Relationships Program (RRRR). This policy also outlines the College's responsibility in ensuring the wellbeing of the school dog and minimizing the risk of harm. See attached 'Risk Assessment' table. (Appendix 1)

## BROAD GUIDELINES

## Ownership and Costs

The College does not own the dogs as they are a family pet. The dog owner is responsible for:

- purchase of dog
- medical costs outside of pet insurance including excess
- food

The school will be responsible for the following:

- pet insurance
- $2 \times$ grooming per year
- further training

The College will engage the services of a trained professional to assess the behaviours and welfare of the dogs, and provide advice regarding strategies to improve their skills, health and wellbeing.

In the case of more than one dog, owners will negotiate to not take leave at the same time if possible. There may be the opportunity to involve other staff members in the training process and this would enable them to also take over the role of handler and carer if the owners are on leave. If an owner leaves the school, the School Dog will also leave as they were purchased by the owner and are a family pet. A new School Dog could then join the program if needed.

## Selection and Training

School pets used for classroom and environmental enrichment do not require approval from the Victorian Schools Animal Ethics Committee (VSAEC). However, the primary concern of the school must be the welfare of these animals at all times, including the provision of care during weekends and school holidays (if applicable) and veterinary care when needed.

When selecting dogs, they will be chosen for their mild temperament, intelligence and their hypoallergenic non-moulting coat. All dogs must have completed basic obedience training and be able to walk on a loose lead. Other qualities should include:

- Friendly
- Confident
- Gentle
- Ease in all situations
- Enjoy human contact

Training of the School Dog is specific and ongoing as they work towards the standards within the public access
test. Training and testing will include a range of experiences such as temperament test, ramps, traffic, schools (both familiar and unfamiliar), entering buildings, stairs, off lead recall with distraction, and basic commands.

A 'safe spot' will be allocated to the dogs where they will spend time if they are not working with students.

## Health

The School Dog will meet medical and vaccination requirements. This will be maintained for their lifetime. They will be regularly groomed and washed as part of their program at school.

The school dogs will be available to work at times when the health and safety of the animal has been prioritised.

## Daily management

Dogs will:

- only attend school if they are healthy
- be kept on lead during times of high human traffic and activity
- be allowed off lead when in a controlled and contained environment
- only be taken off site without the designated person in case of emergencies
- be put on lead and returned to its safe space and/or owner if the dog shows any signs of stress* or unwanted behaviors
* see Appendix 2 for signs of distress behaviors.

Members of our community will be provided with information regarding appropriate behaviours around the dog and hygiene practices. A handler's code of conduct will outline the expectations associated with being the designated supervisor.

## Accident or Injury

In the event of an accident or injury (School dog or member of the school community) the Dog will be removed from the immediate area and taken to their safe area by the designated person if required

- Parents and Owner informed of the incident
- Medical attention will be sought if required
- Incident investigated
